SUBJECT: Appointment of Senior Regional Acquisition Officials (SRAOs)

Applicability. The Regionalization policy applies to all assigned Army Acquisition Corps (AAC) captains and majors.

Proponent. The proponent and responsible agency for this policy is the U.S. Army Acquisition Support Center (ASC).

General. Effective September 29, 2004, the following officers are appointed as the Senior Regional Acquisition Official (SRAO) for the designated regions:

Major General Michael Mazzucchi	Fort Monmouth, New Jersey
Brigadier General Patrick O'Reilly	Warren, Michigan
Brigadier General Paul Izzo	Picatinny Arsenal, New Jersey
Brigadier General Roger Nadeau	Military District of Washington North (Areas north of the Potomac River)
Brigadier General Stephen Reeves	Military District of Washington South (Areas south of the Potomac River)
Brigadier General Samuel Cannon	Redstone/Huntsville, Alabama

The SRAOs are my designated representatives and will coordinate with senior acquisition leaders to ensure that all officers assigned to their regions receive a professional development plan that includes rotation through several areas of concentration that will support diversification and broaden their acquisition knowledge.


Each SRAO will appoint a Regional Account Manager (RAM). The RAM will work directly with the Acquisition Management Branch, U.S. Army Human Resources

Command, to properly track each officer's assignment. Additionally, ASC Regional Directors, in coordination with the RAM, will develop and implement the civilian component of the regionalization process. The ASC Regional Directors are:
