SUBJECT: UPDATED: Change in Mobility Agreement Policy for the Acquisition Corps (AC)

In accordance with the memorandum, SFAE-CM, November 9, 2004, subject: Change in Mobility AC.

Due to the upcoming Base Realignment and Closure Implications and questions concerning mobility, I have decided to extend the Mobility Agreement Policy moratorium for one additional year. The moratorium will now continue through November 9, 2007.

The information contained in the original memorandum remains the same; mobility agreements are mandatory for members of the Competitive Development Group, Acquisition Corps members seeking acquisition Senior Executive Service positions, and other designated key leadership positions. Broadening experiences attained through mobility will continue to be an essential element in career development. This moratorium does not impinge on management's right to reassign personnel for legitimate considerations in the interest of the service.
