#### **Category: Defense Export and Cooperation Journeyman of the Year Award**

**Background:** The 2023 AAE's Excellence in Leadership Award for the Defense Exportability and Cooperation Professional of the Year recognizes the individual whose outstanding contributions and achievements merit special recognition. It also provides an opportunity to showcase the professionalism of the Army Acquisition Workforce.

#### **Eligibility:**

1. Nominee contributions must have been made between 1 June 2022 – 31 May 2023.
2. **Any Defense Export and Cooperation Professional across the Army Acquisition Workforce is eligible as long as he or she:**
  - a. Meets the specific criteria of the award for which they are nominated.
  - b. Performs a Security Assistance (SA)/Armaments Cooperation dedicated mission in their respective organizations.
  - c. Is at the level of a GS-13 equivalent and below.
3. If a member of the AAW, the following requirements must be met:
  - a. Occupy an acquisition workforce designated position.
  - b. Is current, or within the grace period, in their Defense Acquisition Workforce Improvement Act (DAWIA) acquisition career field certification and achieved the required 80 continuous learning points during the prior two-year continuous learning cycle (CL) (1 Oct 2020 - 30 Sep 2022).
  - c. If a member of the Army Security Cooperation Workforce (SCW): Completed SC courses by sequential deadlines in accordance with their position's SCW Certification Level and SC Area of Concentration, along with either meeting the rolling '20 hours of CL the previous two years' requirement or in the two-year CL grace period.
  - d. Must not be a recipient of this award in the past five (5) years.

#### **Evaluation Criteria:**

Nominees must have made a significant contribution during the eligibility period to be considered for this award. This award recognizes the past performance of an individual who has clearly demonstrated exceptional mission accomplishment, selfless service to the United States, extraordinary and uncompromising professionalism and true commitment to the personal and professional growth of others within the command.

Nominations will be considered based on demonstrated excellence and contribution to acquisition mission success in the following areas:

1. Specific achievements within the functional area during the eligibility period. Given that many achievements result from one's efforts and contributions cumulatively over a period of time, achievements that take place over more than the 12-month window may be reported, but the culmination of the work must be within the window. Quantifiable descriptions of achievements are particularly desired. What impact did their action have on the unit or command?
2. **Value of the nominee's contributions** during the award period to the mission of one's organization in supporting one or more of the ASA (ALT)'s priorities:
  - a. Rapid Material Modernization
  - b. New Capabilities
  - c. Robust, Resilient, Secure, and Innovative Industrial Base
  - d. Digital Transformation
  - e. Sustainable Force
  - f. Productive Collaboration
3. Demonstration of leadership including, by example, mentoring and sharing best practices to enhance the success of one's team and the greater acquisition community in achieving acquisition outcome success.
4. **Defense Exports and Cooperation Professional specific criteria:**
  - a. Building cooperative relationships or capacity with our foreign partners, including emerging countries.
  - b. Improve interagency communication and coordination with RDECs and PEOs, other service IPOs, the ASAE and the Office of the Secretary of Defense in support of the mission of the Deputy Assistant Secretary of the Army for Defense Exports and Cooperation.
  - c. Demonstrated leadership and success coordinating and executing key U.S. SA and/or capacity-building programs.
  - d. Demonstrated leadership and technical competence in working with stakeholders across multiple organizations that enhanced the Defense Exports and Cooperation mission.
  - e. Actions that resulted in quantifiable efficiencies or savings to the U.S. Army SA Enterprise and/or international cooperative agreements.

**Nomination Deadline and Submission:**

1. The deadline for nomination submissions is September 7, 2023. **Submissions will not be accepted after 11:59 p.m. ET, September 7, 2023.**
2. Completed nomination packets must be submitted to the U.S. Army Acquisition Support Center (USAASC) Army Director, Acquisition Career Management (DACM) Office through the Web-based call for nominations application at:

**Nomination Packet Requirements and Format:**

1. Signed endorsement memo (one per nomination).
  - a. The senior ranking civilian employee or military official will provide an endorsement letter to describe the nomination.
  - b. Each nomination must have its own endorsement memo addressed to Director, Acquisition Career Management, 9900 Belvoir Rd, Bld 201, Fort Belvoir, VA 22060.
2. Completed nomination form with the following components:
  - a. Narrative
    - Separate sections describing the contributions for each of the four evaluation criteria (specific achievements; value of the nominee's contributions; demonstration of leadership; and Defense Exportability and Cooperation specific criteria).
    - Should not exceed **two** pages.
    - The format will be single-spaced text, Times New Roman, 12-point font, single-sided 8 ½" x 11" page, 1" margins.
  - b. Citation
    - A short summary of accomplishments (not to exceed 200 words). This should be at the end of the nomination form and does not count against the two-page limit.

**Miscellaneous Details:**

1. The nominating point of contact (POC) and/or the organization's award POC will receive an automated email to confirm receipt of a completed submission. Contact the awards coordinator if the POC does not receive a confirmation email within one day after the submission.
2. An appointed panel of judges will select the award winners.
3. The awards will be presented by the AAE at the annual Army Acquisition Awards ceremony in January 2024.
