

FY25 Annual FAL Certification Memo



The Functional Area Leader for Engineering and Technical Management (ETM) and Test and Evaluation (T&E) has signed the annual memorandum certifying that, for the forthcoming fiscal year, the updated competencies reflect the knowledge and skills required to be successful in the functional area (FA); DAU course content is current, technically accurate, and consistent with Department policy; the updated certification standards are appropriate and applicable to all acquisition workforce personnel desiring certification in the FA; and the updated position category descriptions (PCD) are valid for coding acquisition workforce personnel to the FA. All changes were worked in collaboration with Service and Defense Agency representatives through the respective Functional Integration Team and go into effect on October 1, 2025.

The updated competency models and PCDs have been posted <u>HERE</u> and <u>HERE</u>. CLE 030, *Integrated Testing*, will be added to T&E Practitioner certification as a forthcoming requirement in FY25.

New Learning Assets Available!

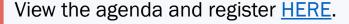
